I write with respect to your note below. Earlier this year I did follow up on what archival material might be in the possession of the Diocese of New Westminster. I had thought that I had addressed this previously, but obviously not. I have attached the following:

- 1. Licensing records from 1932. These are photographs taken by then Archivist Melanie Delva. Her note indicated that there are no licensing records relating to any return to the Diocese in the 1970's.
- 2. The 2015 report of then Diocesan Archivist, Melanie Delva regarding disposition of Joy Kogawa records. They are in the possession of UBC, not the Diocese.
- 3. Email exchanges between Archdeacon Fenton and the Episcopal Church Archivist No records
- 4. Copy of 1994 correspondence (various) between then Diocesan Bishop +Michael Ingham and Joy Kogawa and Bishop Ingham and Cyril Powles. These documents do not appear on Diocesan files but have come to my attention through separate inquiry.
- 5. Letter dated December 28, 1994 signed by G.G. Nakayama. As with #4 above, this document does not appear on Diocese of New Westminster files but has come to my attention through separate inquiry. It is not clear from my investigation whether this letter was ever received by Bishop Ingham.

Any other records of the Diocese of New Westminster that have been provided to me for review consist of communications and reports from 2014 onwards, are not archival and relate to matters involving the JCWG and the Diocese.

I have excluded as well all communications specific to the separate initiative undertaken by the Diocese with respect to the Apology to the Japanese Canadian community regarding the sale of two churches during WW II.

I am satisfied that I have exhausted the archival search that was asked of the Diocese of New Westminster,

including my own investigation and review of Diocesan records (and others). I trust that providing this information satisfies your inquiries.

As you have noted elsewhere, this is "sent to all for open communication".

Dear Steering Committee,

Following up on the archives from Calgary. The target date of August 4th has passed to send the archives over to the Project Office. Looking for an update from Chancellor Crisfield and Archbishop Kerr-Wilson. Two weeks ago the archives from Calgary were fully approved for sending and were fully scanned last year.

The Project Office is **still seeking archival records from the Diocese of New Westminster from Chancellor Cadman and Bishop Stephens**. We are looking for all documents in the Church's possession surrounding Gordon Goichi Nakayama. To date, as far as I know, and after consulting with former members of the Japanese Canadian Working Group, Doug Fenton and the Diocese of New Westminster did not hand over any Church documents regarding Nakayama except for the confession letter. Citations made in this 2014 article titled "Commitment to Truth and Reconciliation" suggest Doug Fenton had Diocese of New Westminster archives at his disposal. Previously it was believed by the Diocese of New Westminster that Doug Fenton handed over all of his documents to the Japanese Canadian Working Group. No such handover took place in 2014 or any year since.

The Healing Fund is waiting for many documents to be shared by the Anglican Church. As we approach the midterm of the Healing Fund project only a single document has surfaced from the Dioceses of New Westminster and Calgary.

I received a call from my friend/colleague at the UBC Rare Books and Special Collections archives this afternoon. Joy Kogawa donated her father's records to them some years back. My colleague is fairly new there and wanted some background on the records and what I knew about them, as I had had contact with UBCRBSP as far back as 2007 regarding Rev. Nakayama. She informed me today that they have just looked at the records in detail for the first time yesterday, and there is a large set of correspondence between Nakayama and his victims – some as children and some into adulthood. She said there is enough to create a list of victims if someone wanted to.

The archives is under pressure from UBC Libraries to make the records public. The archivists are citing our Code of Ethics and Privacy legislation as reasons not to open the records. The archivist who first received the records and is now retired did not follow protocol regarding a legal transfer of the records including the 50 year restriction that Joy put on the records; however I have correspondence in writing from the archivist who took in the records saying that Joy had done so, which I have forwarded to my colleague.

My colleague at Rare Books has a meeting with Mary Kitagawa this afternoon, and will be keeping me in the loop about the situation.

Dear Mark and Colleagues,

The Diocese of New Westminster was asked by the local Japanese Justice Committee Working Group to assist in putting together an historical picture of the ministry of the Revd Canon Gordon Goichi Nakayama.

Nakayama, while canonical resident in the Diocese of Calgary, admitted to a history of child sexual abuse and was deposed in 1995. Nakayama died soon thereafter.

We know that he was invited by Episcopal Church missionaries to Okinawa to accompany them, first in 1949 and then later in the 1950's. We also know that he was told to leave because of some inappropriate behaviour. The correspondance we have was written in the code of the time yet the subtext is clear. Given his history and his own confession we are trying to find out if there was any record. The Bishop of Okinawa has said the stories still exist of Nakayama's 'bad behaviour.'

Is it possible to know whether there is any record of Gordon Nakayama and his work/accompaniment with the Episcopal Church missionaries in Okinawa in the early post-WW II period?

Is it possible to know if there was any record made of the reason he was quickly dismissed and returned to Canada?

I appreciate your kind and candid response.

Dear Michael:

Please excuse the lateness in answering your letter of July 27. We spend most of our time these days at our cottage and only go into town every ten days or so to pick up our mail. Also I didn't want to answer without carefully thinking over what you wrote.

Joy has talked to both Marjorie and me about her father, and when we were in Vancouver at Eastertime we spent a good deal of time on the phone, trying to help her. When we had to leave, we passed her on to Don Grayston, who--you may already know this--has been counselling her. It is a sad story and Joy is such a sensitive person it is doubly and triply hard for her to deal with it.

All in all, I think that your first option is probably the right one. That would be the way most Japanese would handle it. Marjorie reminds me that apologies are taken with great seriousness in Japan, as you can surmise from the unwillingness of many conservative Japanese to make any kind of apology for atrocities committed by their armies during World War II. Apologies are seen as evidence of the sincerity of the individual about wanting to be reinstated into the group.

Quite apart from the consequences for the old man, any public disciplinary action would almost certainly result in some of the victims being exposed, to their shame and disgrace. I wonder whether there shouldn't be some conditions attached to his repentance, such as requiring him to send written apologies to his victims (at least to those he can remember). Such a course would also protect you and the church from the possibility of any future action on the part of one or more of the victims.

I hope that the above may be of some help to you. It seems to be one of the characteristics of those who suffer from the kind of illness Canon Nakayama has displayed that it is very difficult to get them to realize the enormity of what they have done. But, as you say, something has to be done. Marjorie joins me in best wishes and prayers for you in the difficult position you are in.



#### Dear Cyril:

Thank you for your help with the Wheeler business. I think we have everything sorted out now. The position will be offered to John Shozawa, currently in San Francisco, as soon as the parish has sorted out whether they can pay a full time priest. The announcement will probably be made in the fall, and is private for now. Thanks for your assistance with this.

But, alas, another matter has come up and I would very much like your advice.

I had lunch yesterday with Joy Kogawa. She told me about her father's long history of paedophilia. She is writing about it in a book to be released perhaps in two years. It's her personal catharsis to some extent, but she is also greatly concerned about the victims, whom she estimates are in the dozens. She says the situation is known in some parts of the Japanese community, but has been covered up for decades. She told me you know about it too.

Remarkably, there appears to have been no complaint by any victim. However, she says the bishop of Calgary knew about it when Gordon worked there, and many people in Okinawa also knew. It appears he was simply moved in each case.

I feel I have to act on the information she has given me, but there are undercurrents of sensitivity in the Japanese culture a gai jin like me could not understand. I believe I have two options. One is to confront him privately and seek to move him towards some kind of repentance and apology. The other is to take disciplinary action which could perhaps mean the removal of his license as a priest. That could lead to public disgrace for him, and a reaction within the Japanese community here.

As you know, the days of cover up by the church for this kind of thing are over. If any victim chooses to take action after his death, it could be against the church. I feel I have to take some kind of action on their behalf. On the other hand, I am not sure what good would be served by taking public action against an old man near death, except creating a storm of controversy.

My questions are these:

- 1. How do Japanese people deal with this kind of thing in their community?
- 2. What might the consequences be of a disciplinary action against Gordon, at this stage, within the Japanese community?

Joy thinks the consequences on him could be fatal. I am not anxious to cause his death, but at the same time a do-nothing stance would be a further betrayal of those he has abused. There is also the matter of the state of his soul as he prepares to move on.

I know they pay me these big dollars to make these decisions myself, but I would appreciate your comments. Many thanks.
